Andrea Campbell (Democratic Party) is running for election for Attorney General of Massachusetts. She is on the ballot in the Democratic primary on September 6, 2022. Campbell was a member of the Boston City Council in Massachusetts, representing District 4. She assumed office in 2016. She left office on January 3, 2022 (Ballotpedia).

Quentin Palfrey



Quentin Palfrey (Democratic Party) is running for election for Attorney General of Massachusetts. He is on the ballot in the Democratic primary on September 6, 2022. Palfrey ran on a joint ticket with the gubernatorial nominee, Jay Gonzalez (D) in 2018 (Ballotpedia).

Geoff Diehl

Geoff Diehl (Republican Party) is running for election for Governor of Massachusetts. He is on the ballot in the Republican primary on September 6, 2022. Diehl was a member of the Massachusetts House of Representatives, representing the 7th Plymouth District. He assumed office in 2011. He left office on January 2, 2019, and he was a 2015 Republican special election candidate for Second Plymouth & Bristol District of the Massachusetts State Senate (Ballotpedia).

Chris Doughty

Chris Doughty (Republican Party) is running for election for Governor of Massachusetts. He is on the ballot in the Republican primary on September 6, 2022 (Ballotpedia).

Maura Healey

Maura Healey (Democratic Party) is the Attorney General of Massachusetts. She assumed office on January 21, 2015. Her current term ends on January 4, 2023. Healey is running for election for Governor of Massachusetts. She is on the ballot in the Democratic primary on September 6, 2022.
