


"Result of Advocacy" JFK signs Public Law 88-164 in 1963 – Community Mental Health Act



Commonwealth of Massachusetts: House Legislative Districts





Learning How a Bill is Passed



13 Step Process

- 1. There Ought to be a Law
- 2. Bill Filed (3rd January of 1st session)
- 3. Bill assigned to a Committee
- 4. Hearing is Held and Testimony Heard

- 4. Committee Report Directs the Measure's Path - Rejection or on to First Reading
- 5. Bill Read a Second Time, Debate Begins
- 6. Bill Proceeds to the Committee on Bills in the Third Reading
- Bill is Reviewed by the Committee on Bills in the Third Reading
- 8. Bill Read a Third Time, Floor Debate Continues

9. Bill Passed to be Engrossed by one Legislative Branch

10.Second Legislative Branch Considers Bill


11.Amendments Produce Conflicting Versions

- 12.Bill Enacted and Sent to Governor
- 13. The Idea Becomes Law



Tracking a Bill

- Title and bill number and who filed it
- Track bill progress online
- Identify hearing dates
- Organizational support
- Opposition to bill
- Cost to fund bill



How Legislation Begins

- Filing deadline for new bills 3rd Friday of January in 1st session
- Budget bill H1
- Bills assigned to committees
- Tracking bills: https://malegislature.gov/Bills/Search
- Hearings
- Full process

Tips on Testifying on a Bill for 3 minutes



What to know - What to expect - What to say

After Bill Filing

- Obtain co-sponsors to show support
- Develop fact sheet, consider briefing
- Testify at committee hearing (each bill goes through committee)



After Bill Filing

- If costs involved, need to advocate with Ways/Means
- Letter writing, emails, visits to advance vote on bill


